- **Hard hats to PAS015 or EN1384 must be worn, with chin straps fastened, at all times when mounted.**
- **Back protectors, compliant with current regulations, are advisory on all mounted activities and schooling and are mandatory for cross-country competitions and schooling.**
- Horses are easily frightened and can be dangerous. Please support us in ensuring members of the public are requested to keep clear from the horse areas and to avoid behaviour, which might alarm horses.
- If at any time you are aware, in any way, of circumstances that might cause alarm, distress or injury in any way to any persons or animal, you are obliged to notify ALL users in the area and the management on **07836 369908** without delay. Failure to do so will incur your liability in any subsequent event. Calls will be logged and recorded in order to substantiate events and you hereby agree to these recordings.
- Save for the death or personal injury caused by the negligence of H. C. Bucknell & Co Ltd or anyone for whom they are in law responsible, neither the agent, employee or representative of H. C. Bucknell & Co Ltd accept any liability for any loss or damage, accident, injury or illness to horses, owners, riders, spectators, vehicles or any property or persons howsoever arising at an Alden Equicentre event/training session or activity.
